IN THE NAME AND BY THE AUTHORITY OF THE STATE OF TEXAS BEFORE ME, the undersigned authority, on this day personally appeared R. Almaguer #2172, who after being by me duly sworn, on oath deposes and says that he has good reason to believe and does believe that heretofore to wit; on or about the 3RD day of September 2025 and before the filing of this complaint in the County of El Paso, the State of Texas, one Max Elijah Grossman, Hereinafter called the DEFENDANT, did then and there unlawfully, A person (defendant) commits an offense if the person (defendant) intentionally, knowingly, or recklessly caused bodily injury, to wit by pushing vi-01 using both his hands (open hands) about her breasts causing her pain and discomfort, with to another, to wit: victim (


Officer R. Almaguer #2172 working as AUX-707 was advised by front lobby desk (Valerie) of a walk-in report reference assault family violence. Officer met with vi-01 who advised defendant had assaulted her by pushing her using both of his (defendant) hands (open hands) about both of her breasts causing her pain and discomfort. Vi-01 advised she had the suspicion that defendant was cheating on her with other women. So, vi-01 then asked defendant if he was cheating on her. Vi-01 advised defendant got irate and that was when defendant pushed about both of her breasts causing her pain. Vi-01 advised she had a procedure done in late July 2025 reference "breast implant removal and reconstruction" in Juarez, Mexico and is still in the process of healing when the incident occurred. Vi-01 advised both her and defendant have been having issues with their relationship for "sometime" and recently defendant had "broken-up" with her but were still living in the same household. Vi-01 advised they both share a 2-year-old baby (female).

Vi-01 advised after the assault occurred, she took "over the counter" Tylenol for the pain. Vi-01 advised the next morning (28<sup>th</sup> of August) she noticed swelling to her left breast along with pain and soreness to both her breasts. Vi-01 advised on Saturday the 30<sup>th</sup> of August she then proceeded to the Upper Valley Urgent Care Center because of the pain and swelling to her left breast. Urgent Care gave her some antibiotics and referred her back to her surgeon (doctor who administered her breast surgery) on a follow-up. Vi-01 advised on September 1st she then proceeded to her doctor in Juarez, Chihuahua, Mexico and doctor had run some exams and learned that she sustained a hematoma to her left breast.

This offense occurred in the City and County of El Paso, Texas against the peace and dignity of the State.
